Konda began her career with what was then the Murray Ohio Savings Association in December of 1986. Over the course of the last 39 years, she has served in every department of the credit union and has been the driving force for immense changes in daily operations and member services. Konda was named the third President and CEO of ERCU in October of 2008, maintaining two branch locations and an asset size of 19 million.



As CEO, Konda lead ERCU through many major events. The start of our checking account program, including all of our current member services, community charter conversion, 2 name changes, 4 additional branches, 2 mergers, and an asset size of 181 million are just some of the landmarks of her leadership. Her dedication to our members and staff has been unwavering throughout the years. In April of 2025, Konda was inducted into the Credit Union Hall of Fame. This accolade stands as a testament to the impact she has had on ERCU as well as our community as a whole.

We are thrilled that she will continue serving ERCU as a member of our Board of Directors.
